This article states that it "takes an average of 3½ years to complete the designation process."

It also states "An application could be made by January 2019 for federal funds to do the required National Heritage Area study and complete details such as setting boundaries and writing a financial plan."

Generally, overlap exists if the resources intersect/overlap, such as Erie Canal, Hudson River, and Lake Champlain. Those three resources intersect in the Albany NY area.

South Catalonia overlaps with Gullah Geechee in South Carolina.

Many others come close or are neighbors but generally, we don't encourage overlap if there isn't a strong reason for the overlap as that can be confusing to the public etc.

We had an emerging area that NPS had a negative finding called the Southern Campaign of the American Revolution that was proposed for North Carolina and South Carolina. The draft map of the area at one stage was going to overlap 3 existing areas.

The O Pioneers would need to make a strong argument in their feasibility study as to why these resources need to be in the proposed NHA and if they are not already interpreted in the existing NHA.

We are thrilled...on December 13<sup>th</sup>, during the third of three NHA Ad Hoc Steering Committee meetings, all twenty participants voted yes to conduct a National Heritage Area (NHA) Feasibility Study.

Before the vote there was much excitement and in depth discussions around national significance and themes. Among the ideas discussed where migration, crossroads of the Great Plains or America, America's Heartland, The Great American Desert, and so on.
